Home Visitors Presentations

Joe Damato, home visitor coordinator, for client #1, prior discussion at June 2, 2025 board meeting (see minutes), lives at Oxford House, age 53, was assisted by Hope Sheds Light to find a new job. Board had approved \$380 for two weeks rent. Since then, had car accident, can't use car, spending \$40 per day for Uber to get to work, requests another \$190 for rent. Board declined, already helped client. Suggest client contact Hope Sheds Light for assistance.

Tom Jones, client #2, lives at Hopes Crossing, single parent with three year old child, separated from spouse, used all saving and unemployment for court costs to obtain some custody of child – not a good situation living with the spouse. Currently unemployed, went to school for CDL license (Commercial Drivers License), completed but needs to take the road test. Once passed, client has job lined up for the end of October with income of about \$50k. Requests – September rent \$213 plus car payment of \$785 = \$998. Board approved.

Gemma Brennan, client #3, age 39, won lottery for an apartment in Forked River. Currently lives on Washington Street, not a safe area, has teen age child attending high school. Dawn, case worker from Bright Harbor Healthcare, brought case to Gemma, intake form completed by Gemma, and presented to the board. Requested \$830.50 to move by October 1. Washington Street is St. Joe's territory. Board advised to forward case to St. Joe's.

Updates on clients:

#4, discussed at August 25 board meeting (see minutes), was requesting \$1850 to move from Silverton to Lena Road. Further information had to be developed. Client decided not to move. Case closed.

#5, discussed at August 25 board meeting (see minutes), client will find out today if able to obtain apartment at James Street Apartments. Currently living in hotel. Providence House paying for 28 days as there was an issue with another client also staying at Providence House.

Financial support to clients at this meeting = \$998 (Bryant).

Sharon Bianchi, treasurer: reported on checking account balance and weekly deposit.

- -Parish well repair bill = \$2350. Tabled for discussion at next board meeting.
